

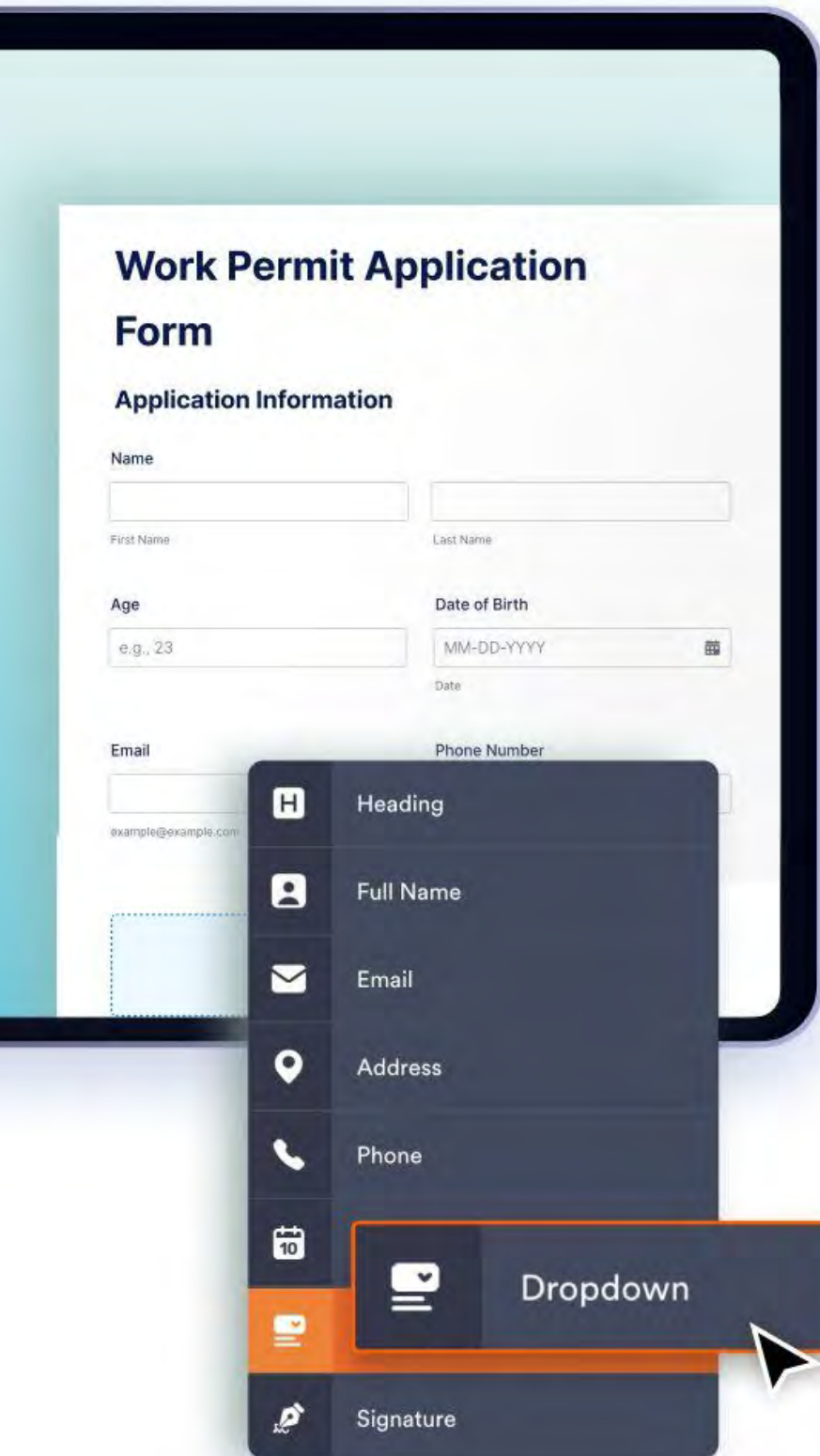

3 steps to digital transformation

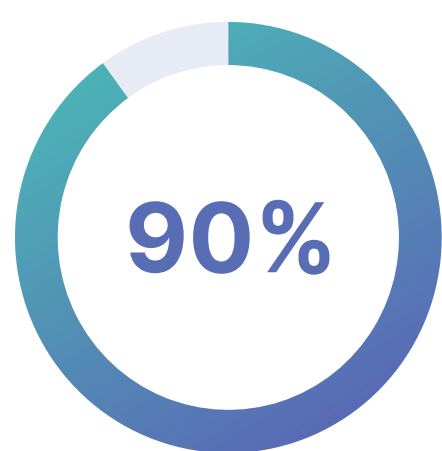
1. Ditch the paper

Inefficient paper-based processes slow down government operations, leading to costly delays and wasted resources. The shift toward digitization allows governments to increase productivity, save money, and improve service delivery to communities.

Reducing paper use is also good for the environment. The [average American worker generates](#) 10,000 sheets of office paper every year. As a result of legacy paper systems, the pulp and paper industry accounts for about [5 percent of the world's greenhouse gas emissions and uses about 4 percent of the world's energy](#). The fastest and easiest way to reduce your organization's paper usage is to digitize paper forms.

Digitizing paper forms and processes can have an immediate impact by eliminating the costs of paper, printing, and storage. Maintaining paper processes takes time, effort, and money. According to the [U.S. Chamber of Commerce](#), paper forms cost the government \$38.7 billion annually. Jotform Government is dedicated to reducing this financial burden for government agencies and educational institutions, using the technology developed for Jotform Enterprise.

For example, [Odyssey Charter Schools](#) has achieved significant savings by adopting technology to replace manual processes. According to Melanie Dunlop, educator and Jotform Enterprise project manager, the schools were able to “repurpose \$30,000 worth of fire-proof cabinets because we’ve replaced our 60-page paper registration packet with online forms.”

[The County of Marin](#) in California implemented Jotform Enterprise to digitize paper processes, manage event registration, and securely monitor community health. During the COVID-19 pandemic, the county’s health department created online forms using Jotform Enterprise to screen people for COVID-19 vaccination and testing appointments.

Marin County’s transition to paperless processes allowed staff to streamline operations with secure online forms and boost overall efficiency. Many departments are also moving away from using DocuSign in favor of Jotform Sign, the native e-signature solution available at no extra cost — and with no limits on the number of signatures — to all Jotform Enterprise and Jotform Government users.

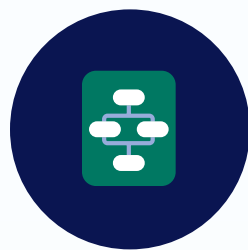

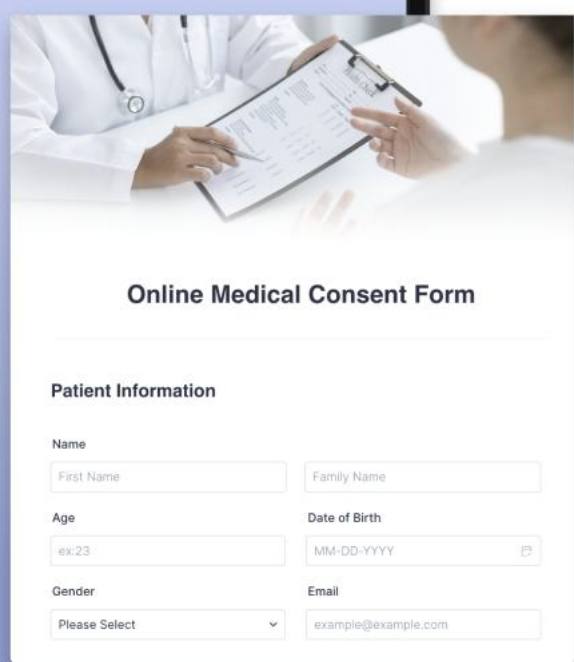

2. Streamline user experience and internal processes

Accessing government services usually starts with a form, whether someone is paying for utilities or applying for a driver's license. Most internal administrative processes, like performance reviews and job applications, also start with forms. The benefits of digitizing your government agency's forms can both streamline services for citizens and simplify internal processes for employees.

Streamlining government services

Providing citizens with easy-to-navigate online portals and forms can significantly boost the user experience by reducing the friction associated

with accessing government services. According to Deloitte's Government Trends 2024 report, digital technology in government offers the opportunity for "10x-level improvements" in customer experience.

Digitizing government services

The Port of Oakland, for example, has leveraged Jotform Enterprise to digitize its permitting process for over 8,600 parking spots at San Francisco Bay Oakland International Airport. Its new process links online forms, e-signature collection, payment capture, and approval workflows for a single, cohesive, automated solution. This solution not only dramatically decreases the time and effort required from Port of Oakland employees during permitting but also makes the process much faster and more convenient for customers.

“With Jotform Enterprise, we created an end-to end parking application. Applications are routed to the employee’s primary supervisor for approval upon completion. Once that supervisor approves the application, Jotform routes it to our department, where we can provide final approval and prepare employee parking permits for pickup.”

Simplifying administrative processes

Online forms are much more convenient not only for citizens but for government employees as well. Online forms can simplify and automate internal processes that require data collection, such as performance reviews, work assessments, and job applications.

Daniel Mateo, assistant superintendent of Miami-Dade County Public Schools, has leveraged Jotform Enterprise to streamline Miami-Dade’s payroll, attendance, paid time-off scheduling, IT support tickets, event planning, and more. “When I have a problem I need to solve,” he says, “my first thought is: Can I do this with Jotform?”

The City of Chandler, Arizona, is another example of supercharging administrative processes with digital automation. Fernanda Acurio, the city's human resources manager, has used Jotform Enterprise to automate a number of previously paper-based city processes. Chandler's open enrollment process, for example, is now entirely digital and includes a form with 134 different conditional logic rules. Using conditional logic, Acurio can automatically tailor forms to different employees, improving the user experience.

We also use a complex workflow for our public safety referral program. After employees submit a form, it automatically flows to HR for approval. We've also built a probation period into the workflow, automatically reminding employees to complete the form after a certain period of time.

3. Bolster internal data security architecture

Properly securing your data is the final and arguably most important step in the digital transformation process. According to [CyberEdge](#), 68.2 percent of governments were compromised by at least one successful cyberattack in 2022, and the number of attacks on local and state governments increased in [2023](#). Upholding stringent data security standards protects your citizens' privacy and instills trust and confidence in your institutions.

Building out safe digital data collection processes requires a complex and nuanced approach to security. More than simply enforcing the use of strong passwords, securing data for governments requires meeting a host of regulations and upholding strong internal security practices.

Share your forms

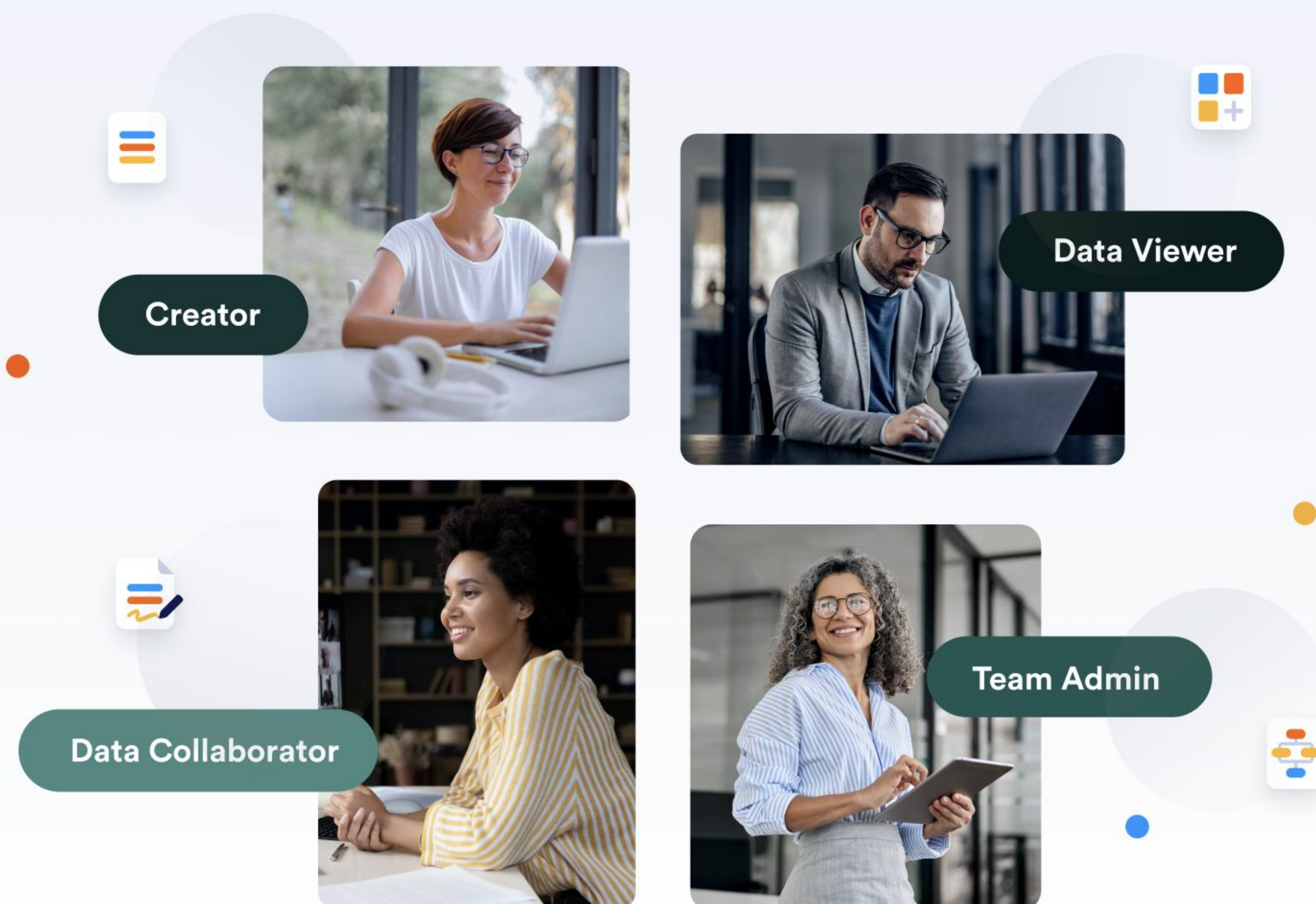
